





Annual Economic Base Jobs Needed

The table below projects the number of economic-base jobs needed to sustain projected population growth and achieve full employment (5% unemployment) with 45% of the workforce employed in e-base jobs.

In 2012, McKinley County had a total workforce of 26,577. This number represents 36.4% of the total population. The unemployment rate was 8.7%, the fourth highest among the state's 33 counties. The formula indicates that nearly 2,200 new e-base jobs will be needed over the next ten years, or approximately 219 per year.



Gallup Target Industry Analysis - "Best Fit" Industries

Oil / Gas/ Mining Equipment & Services

- Direct access to I-40
 & existing rail spur
 off of the BNSF main
 line.
- Access to the Four Corners Region.
- Existing transload operation at Gamerco.
- Strong potential subsectors.
- Good labor availability.
- Need for specialized training.

Warehouse / Distribution (DC)

- Direct access to I-40 and existing rail spur off of the BNSF main line.
- Market access to the West and access to the Four Corners Region.
- May not be right for retail or ecommerce DC's due to distance to large metro areas.
- Good unskilled labor availability and low wages.

Industrial Machinery

- Good potential for many types of manufacturing.
- Good labor availability, but some skilled labor concerns.
- Need for specialized training.
- Good sites with rail.

Plastic Products


- Good availability of unskilled workers.
- Good site with rail for transport of plastic pellets and I-40 access.


Food Processing

- Access to NAPI and lack of rail in Farmington.
- Potential of 'food in a box' containerization and transload at rail sites.
- Greenhouse niche is a possibility.
- Water and wastewater capacities are a concern right now, but are being addressed.
- Need for specialized training.
