PURPOSE:

GGEDC's 2nd "Roundtable" of Fiscal Year 2024 follows up on the Roundtable held in Santa Fe on January 26th, 2024. This second gathering includes an interim report of findings by the Inland Port consultant team of John C. Martin Associates (Jeff Sweeney, Project Manager) and Hatch Consultants (Joshua Nelson, Engagement Manager), focused primarily on market and feasibility analysis. It will also introduce to you the consultants selected for the other "pieces of the puzzle" in the McKinley County TradePort initiative — for the Autonomous Vehicle Test Track, the Hydrogen Fuel Hub, and the Foreign Trade Zone/User Fee Airport designation.

BACKGROUND:

The January 26th Roundtable included outstanding presentations by Western Hemisphere trade expert Patrick Schaefer; International Trade experts Matt Beier (Transatlantic Business Investment Council) and Jim Blair (Navigator Consulting); Inland Port experts Jeff Sweeney (Martin Associates) and Joshua Nelson (Hatch Consultants); and New Mexico Governor Michelle Lujan Grisham. These presentations provided a substantial overview of the Greater Gallup community's bold vision of positioning Gallup/McKinley County as a logistics hub and inland port serving the global supply chain. This June 7th Roundtable takes a look at what the consultants have been researching and points toward issues and goals to be tackled in the coming months.

The Gallup/McKinley County Regional TradePort: Progress Report

June 7, 2024 Gallup, NM

Amid world-shaking changes in the global economy, which impacted us greatly in the Greater Gallup region, the Greater Gallup EDC and its partners maintained a steady – but flexible and innovative – course of proactive planning and development. In light of these changes, along with new information, new technology and new opportunity, we sometimes had to shift gears, revise our expectations and re-set our direction. But it was always focused on promoting economic-base industry, taking advantage of Gallup/McKinley County's unique assets: our location along the I-40/BNSF Railway corridor at strategic distances from major urban centers and logistics hubs, representing major transportation and logistics potential; our available land for development; our history in the energy industry; and our capable but under-employed workforce.

All of this planning work has led to the current initiative to unite and coordinate our efforts under the banner of an "inland port" complex. This fiscal year's first Economic Roundtable was held in Santa Fe in January, where we were treated to a first-class education in global trade as it relates to our efforts in Gallup and McKinley County. In early 2024, several consultant teams were coming on board to address, in tandem: the Inland Port complex itself; an Autonomous Commercial Vehicle test track; a Hydrogen fuel hub; and a Foreign Trade Zone. As a way of building momentum and coordination among these initiatives, it was decided to hold a second Roundtable – this one to be held locally in McKinley County – in the late Spring. This second gathering is now at hand.

It is now pretty generally known and accepted that Gallup and McKinley County have some assets and some opportunities related to their transportation/logistics facilities. But the challenge is to <u>optimize</u> this potential by putting in place actual facilities and capacities that directly respond to market demand in the logistics field. That means having the necessary infrastructure, the regulatory tools, the technology, the partnerships, and the political and financial support required to attract investors and industry to the community. Pulling all of that together is a complex process that takes time, resources and ... good fortune. We think fortune is smiling on us, and it's up to us to take advantage!


To create a "critical mass" of ready-to-go industrial capabilities in the Greater Gallup region, we are simultaneously working on weaving together a number of separate – but interrelated – initiatives, all with the overall goal of building up the Gallup/McKinley County economy and generating thousands of jobs over time:

Carbon Coal Road Reconstruction – now complete, providing a state-of-theart, heavy-haul, multi-use truck route serving the Gallup Energy Logistics Park and other developments along that 5-mile corridor;

- Repurposing of the coal-fired Escalante Generating Station to use Hydrogen as an energy and fuel source;
- McKinley County Business Park a county-owned site, being prepared Fto stand up a business park facility to accommodate public and private economic development entities working in the Carbon Coal Corridor;
- ➤ A freight trucking "Super Center" to meet the 21st century needs of the trucking industry, including computer facilities, modern amenities and accommodations, multiple fuel stations;
- Hydrogen and Electric Vehicle refueling stations;
- > A state-of-the-art Test Track for Autonomous Commercial Freight vehicles;
- Designation of the Gallup Municipal Airport by US Customs as a Foreign Trade Zone and User Fee Airport; and
- A comprehensive inland port complex, developed in phases, to attract manufacturing, warehousing and other industries and to serve as a logistics hub to accelerate supply chain flow from West & East Coast and Gulf Coast seaports, and to tap into both trans-Pacific and trans-Atlantic trade.
